**Friday, January 2, 1920**

Frank Piper left for Detroit Saturday.

**Friday, May 7, 1920**

S. Piper returned last week from Detroit, where he spent a week with his son Frank, who is in Receiving Hospital with an injured foot.

**Friday, May 14, 1920**

Mrs. Samuel Piper went to Detroit visit her son Frank, who had his foot crushed in street car accident May 12. The foot became infected and for a few days his case was very serious. Late reports show that he is improving slowly.

**Friday, May 21, 1920**

The condition of Frank Piper, who had his foot crushed in a street accident in Detroit on April 2, is not very satisfactory. The foot was amputated on May 10, and since then erysipelas has set in and he is very sick boy. His mother, Mrs. Samuel Piper is still with him.

**Friday, May 28, 1920**

The funeral of Frank Piper, the 18 year old son of Mr. and Mrs. Samuel Piper, whose serious illness was noted in these items last week, was Thursday at the Presbyterian Church with Rev. Boyce in charge of the services. Frank was injured in a street car accident on April 2, in Detroit, the amputation of his foot being necessary later. Erysipelas developed and the illness proved fatal, death occurring May 18. His mother was with him during his illness and brought the body home. The parents, three brothers and two sisters survive.

He alighted from a Detroit car and was struck by another car, his foot being badly crushed. Report from Receiving Hospital Monday evening said they could not say yet as to whether

they could save the foot or not. Mr Piper left for Detroit Sunday and will remain there until his son's condition improves.

**HIT BY STREET CAR  
ALCONA YOUNG MAN DIES**

***Frank Piper Passed Away Tuesday in Detroit, Funeral Today***

Frank Piper, 18, son of Samuel Piper of Alcona township, died Tuesday morning in Detroit, as the result of being hit by a street car some weeks ago. His foot was crushed and about a week ago the member was amputated. The young man seemed to be getting along all right and his recovery was expected. The remains were brought to Black River Wednesday, accompanied by the mother, who had been at her son's bedside, and Wm. Piper, an uncle. Funeral services will be held today (Thursday) at 2 p.m. from the Presbyterian church in Spruce.
